## NHK Spring Invests in Kanagawa Prefecture's "Green Bonds"

NHK Spring Co., Ltd. (Head Office: Yokohama; President and COO: Kazuhisa Uemura) is pleased to announce its decision to invest in green bonds issued by Kanagawa Prefecture for the fourth consecutive year.

Kanagawa Prefecture is home to 26 of our domestic group sites, where approximately 4,700 employees—representing about half of our domestic workforce—are based. Through this investment, NHK Spring aims to actively support initiatives that improve the natural environment and strengthen disaster prevention measures in the region — a key operational base for the company.

Contributing to the sustainability of Kanagawa Prefecture is expected to create synergies with NHK Spring's core business activities and further enhance the company's contributions to the local community.

NHK Spring remains committed to contributing to the realization of a sustainable society through its business operations and will continue to support environmental and social initiatives aligned with this goal.

In February 2020, Kanagawa Prefecture formulated its Kanagawa Prefecture Water Disaster Prevention Strategy as a measure against water disasters such as heavy rains and typhoons caused by climate change. In September of the same year, to promote the strategy, it established a Green Bond Framework.

In March 2023, in consideration of the environment-related changes since the strategy's formulation (such as intensifying climate-related disasters, the Embankment Regulation Law, COVID-19, and advancements in disaster response through digitization), Kanagawa Prefecture revised its Water Disaster Prevention Strategy to further strengthen its measures.

Along with this revision, the framework was also updated, and the eligibility for project funding has been expanded. The funds raised through the issuance of these bonds are scheduled to be allocated to the following projects related to the Kanagawa Prefecture Water Disaster Prevention Strategy.
